

## Zyterge Base PW

NEW GENERATION POLYMERIC AGENT FOR **ENZYME WASHING** OF DENIM FABRIC.

**Zyterge Base PW** is a new generation non-ionic polymer designed for effective removal of unfixed indigo dye from denim fabric.

Non-ionic polymer based solution gives stable suspension of indigo blue dye particles released during washing process in bath. The product is stable with Amylase enzyme rinse (desize) to remove the starch, improve wetting and soften the fabric.

Due to an **excellent suspension** and **anti-redeposition** nature it keeps starch, indigo dye and other foreign particles in stable suspension without getting re-deposited on stitched polyester-cotton fabric. This results in improved pilling resistance, whiteness, and hydrophilicity of the stitched pocket fabric.

## **Preparation of 30% solution of Zyterge Base PW:**

- a. Take 3X gm of **Zyterge Base PW**
- b. Add 7X gm of water at RT
- c. Stir it for 15—20 min and whitish viscous solution will be formed.

## **Application:**

**Denim washing** : **Zyterge Base PW 30 %** should be used at 0.5 – 1.0% on the weight of the bath.

## **Procedure:**

Amylase	→ 0.2% on the wt of fabric
Material liquor ratio	→ 1:6
Temperature	→ 70°C
Zyterge base PW (30% Sol.)	→ 1% on the wt. of the bath

**Zyterge Base PW 30%** is concentrated product. It should be pre-diluted in water before adding to denim washing enzyme bath. Compatibility of chemical bath needs to be checked.

## **Storage:**

- At room temperature, the solution has thickening tendency. So mixing is necessary before further use.
- Keep the drums of **Zyterge Base PW** in a cool shade. Do not store in direct sun or at a temperature higher than 40°C.
- In case the drums are open and are intended to be stored for a longer time, ensure to tie and seal the mouth to avoid moisture contact. Minimum shelf life is 6 months.
